## Global Market Wrap

Bursa saham Wall Street pada perdagangan awal pekan ditutup menguat dengan volume perdagangan yang lebih rendah karena pelaku pasar membeli beberapa sektor yang kurang menguntungkan pasca pemilu. Dow Jones ditutup menguat 39 poin (+0,20%) di level 19.883, sedangkan Nasdaq naik 20 poin (+0,37%) pada level 5.457. Dari Regional, indeks Nikkei dibuka menguat 7 poin (+0,04%) pada level 19.399. Nilai tukar Rupiah terhadap USD pagi ini dibuka melemah 4 poin (-0,03%) di level Rp13.393.

## Technical Ideas

Menguatnya bursa saham Wall Street serta harga minyak mentah diprediksi menjadi sentimen positif indeks. Di sisi lain, minimnya sentimen positif dalam negeri diprediksi menjadi katalis negatif indeks. IHSG diprediksi bergerak menguat terbatas dengan target support di level 5.160 sedangkan resist pada level 5.220. Beberapa saham yang bisa dicermati antara lain:

- LPPF (Spec Buy, TP: Rp15.300, Support: Rp14.600)
- JSMR (SELL, Resist: Rp4.510, Support: Rp4.350)
- SCMA (SELL, Resist: Rp2.590, Support: Rp2.430)
- JPFA (SELL, Resist: Rp1.690, Support: Rp1.570)

## News Highlight

**PT Red Planet Indonesia Tbk (PSKT)** berencana menambah modal dengan HMETD senilai Rp410 miliar. Sebagian dana akan digunakan untuk membayar utang. Sebanyak Rp142,81 miliar dana hasil right issue akan digunakan untuk membatasi utang ke PT Bank CIMB Niaga Tbk. Sementara itu, sebanyak Rp141,2 miliar juga digunakan untuk membayar utang ke pihak berelasi. Dengan kata lain, sebanyak 70% dana hasil right issue akan digunakan untuk membayar utang. Sisanya digunakan untuk membangun proyek baru sebanyak Rp110 miliar dan jumlah tersisa untuk modal kerja.

**PT Citra Marga Nusaphala Persada Tbk (CMNP)** berencana membagikan dividen saham dengan rasio 9:2. Dividen saham yang akan dibagikan berasal dari dana cadangan yang belum ditentukan penggunaannya. Dana tersebut mencapai Rp1,02 triliun per 31 Desember 2015. Pembagian dividen saham diharapkan dapat meningkatkan peredaran saham perseroan serta meningkatkan likuiditas perdagangan saham di npasar modal. Hal itu akan mendorong peningkatan value dari pemegang saham.

**PT Bakrie & Brothers Tbk (BNBR)** menambah modal tanpa hak memesan efek terlebih dahulu melalui konversi atas obligasi wajib konversi (OWK) sebanyak 3,3 miliar saham. Harga pelaksanaan aksi korporasi itu sebesar Rp50 per saham. Dengan begitu, total transaksi mencapai Rp165 miliar. Penerbitan saham baru itu langsung diserap oleh kreditur BNBR, Daley Capital Limited. Pelaksanaan non-HMETD tersebut memang dilakukan dalam rangka penyelesaian pinjaman perseroan. Selain menerbitkan OWK, BNBR juga masih berupaya untuk mengurangi utang dari kreditur lainnya. Sekitar 80%-90% proposal restrukturisasi sudah diterima oleh kreditur.

**PT Bumi Resources Tbk (BUMI)** merancang pembangunan proyek pembangkit listrik tenaga uap (PLTU) berkapasitas 3.000 megawatt. Manajemen BUMI mengklaim telah mengantongi perizinan untuk proyek tersebut. Manajemen menargetkan akan membangun PLTU terutama di wilayah pertambangan perseroan. BUMI akan mengajak mitra strategis, salah satunya dari China. Pendanaan untuk pembangunan proyek PLTU akan diperoleh dari pinjaman perbankan asing.
