Global Market Wrap

Bursa saham Wall Street pada perdagangan akhir tahun ditutup melemah setelah ketiga mayor indeks mencatatkan penurunan selama tiga hari. Dow Jones ditutup melemah 57 poin (-0,29%) di level 19.762, sedangkan S&P 500 turun 10 poin (-0,46%) pada level 2.239. Dari Regional, indeks Nikkei dibuka melemah 31 poin (-0,16%) pada level 19.114. Nilai tukar Rupiah terhadap USD pagi ini dibuka melemah 20 poin (-0,14%) di level Rp13.492.

Technical Ideas

Melemahnya IHSG pada penutupan akhir tahun karena aksi jual oleh sebagian investor pasca window dressing diprediksi menjadi sentimen negatif indeks, di sisi lain, adanya katalis positif dari Januari efek diperkirakan dapat mendorong laju indeks. IHSG diprediksi bergerak melemah terbatas dengan target support di level 5.270 sedangkan resist pada level 5.335. Beberapa saham yang bisa dicermati antara lain:

- BBTN (SELL, Resist: Rp1.770, Support: Rp1.710)
- ITMG (Spec Buy, TP: Rp17.150, Support: Rp16.600)
- MPPA (Spec Buy, TP: Rp1.525, Support: Rp1.435)
- HMSP (SELL, Resist: Rp3.920, Support: Rp3.740)

News Highlight

PT Sierad Produce Tbk (SIPD) yakin bisnisnya masih dapat tumbuh pada tahun 2017. Melihat prediksi konsumsi masyarakat kelas menengah yang naik, emiten berani mematok target yang cukup tinggi. Untuk tahun depan Sierad mematok pendapatan dapat tumbuh 35% dari tahun 2016 dan laba bersih diproyeksi naik 33% dari tahun lalu. Tahun 2016 SIPD mematok target pendapat sebesar Rp3,2 triliun dengan laba bersih sekitar Rp42 miliar. Untuk belanja modal tahun ini SIPD mengalokasikan dana sebesar Rp225 miliar.

PT Bumi Resources Tbk (BUMI) akan menggelar penambahan modal dengan memberikan Hak Memesan Efek Terlebih Dahulu (HMETD) maksimal sebesar 37,88 miliar saham baru. Nilai transaksi itu diperkirakan mencapai Rp35,1 triliun. BUMI akan menggunakan seluruh dana yang diterima itu untuk melunasi kewajiban utang terakumulasi perseroan sesuai dengan keputusan PKPU. Aksi korporasi ini memberikan efek dilusi sebesar 50,8% terhadap pemegang saham laam yang tak mengambil haknya dalam HMETD tersebut.

PT Sekar Bumi Tbk (SKBM) akan melakukan penawaran umum saham baru untuk penanaman modal dengan memberikan hak memesan efek terlebih dahulu. Rencananya, dana yang terkumpul akan digunakan untuk pembayaran atas pengambilalihan 22.500 lembar saham SBB milik Clareville International Limited atau setara 90% saham yaitu sebesar Rp268 miliar. Sebesar Rp125 miliar akan digunakan untuk tambahan penyertaan modal SBB. Kemudian anggaran Rp120 miliar akan digunakan untuk tambahan penyertaan modal entitas anak yaitu BPU.
