Global Market Wrap

Bursa saham Wall Street pada perdagangan hari Kamis ditutup melemah karena ketidakpastian akan kebijakan yang diambil Presiden Donald Trump membuat pelaku pasar cenderung untuk istirahat sejenak, meskipun data ekonomi tetap solid. Dow Jones ditutup melemah 43 poin (-0,21%) di level 19.899, sedangkan Nasdaq naik 11 poin (+0,20%) pada level 5.488. Dari Regional, indeks Nikkei dibuka melemah 100 poin (-0,52%) pada level 19.420. Nilai tukar Rupiah terhadap USD pagi ini dibuka menguat 20 poin (+0,15%) di level Rp13.350.

Technical Ideas

Melemahnya bursa saham Wall Street serta diprediksi menjadi sentimen negatif indeks, di sisi lain masih menguatnya harga minyak mentah serta nilai tukar rupiah diperkirakan menjadi katalis positif indeks. IHSG diprediksi bergerak menguat terbatas dengan target support di level 5.300 sedangkan resist pada level 5.360. Beberapa saham yang bisa dicermati antara lain:

News Highlight

PT Semen Indonesia Tbk (SMGR) menyiapkan belanja modal sebesar Rp6 triliun tahun ini. SMGR akan menggunakan sebagian besar belanja modal untuk ekspansi pembangunan pabrik di sejumlah daerah. SMGR akan menutup 40% kebutuhan belanja modal dari kas internal dan sisanya dari utang bank maupun obligasi. Bahagn pembiayaan dari eksternal ini bisa membengkok menjadi 70%. Semen Indonesia akan menggunakan sisa dana belanja modal untuk penyelesaian pabrik di Indarung dan Rembang. Namun, pabrik Rembang masih tersangkut masalah pembatalan izin lingkungan oleh Mahkamah Agung.

PT Perusahaan Gas Negara Tbk (PGAS) membangun pipa gas bumi ruas Gresik-Lamongan-Tuban sepanjang 141 Km. Perseroan akan terus agresif dalam membangun jaringan pipa gas bumi untuk memperluas pemanfaatan gas bumi ke masyarakat. Dalam pembangunan jaringan gas bumi, perseroan butuh dukungan dari pemerintah pusat daerah serta masyarakat karena selama proses pembangunan pipa gas terkadang menimbulkan rasa kurang nyaman bagi masyarakat pengguna jalan ketika pipa ditanam di pinggir jalan. Pembangunan proyek pipa gas bumi di Jawa Timur ini juga sekaligus komitmen perseroan untuk membuka wilayah-wilayah pasar gas bumi baru di Jawa Timur.

INDOPREMIER

PT Soechi Lines Tbk (SOCI) membidik pendapatan sebelum pajak pendapatan sebelum bunga, pajak, depresiasi, dan amortisasi atau EBITDA sebesar US\$60 juta tahun ini. Proyeksi tersebut terbilang konservatif karena bisnis angkutan minyak dan galangan kapal diestimasi berjalan stabil sejalan dengan model bisnis perseroan yang berbasis kontrak. Di bisnis galangan kapal, tahun ini SOCI akan fokus mengerjakan delapan pesanan kapal senilai US\$110 juta. Permintaan pembuatan kapal sebetulnya tidak berhenti mengalir. Namun, perseroan perlu menyesuaikan pesanan dengan kapasitas galangan, termasuk diantaranya sumber daya manusia dan quality control.
