Global Market Wrap

Bursa saham Eropa pada perdagangan awal pekan di tutup melemah karena pelaku pasar menunggu rincian lebih lanjut mengenai rencana Brexit UK dan pelantikan presiden terpilih Donald Trump minggu ini. DAX ditutup melemah 74 poin (-0,64%) di level 11.555, sedangkan FTSE ditutup melemah 10 poin (-0,15%) pada level 7.327. Dari regional, indeks Nikkei dibuka melemah 124 poin (-0,65%) di level 18.970. Nilai tukar rupiah pada hari ini dibuka melemah 3 poin (-0,02%) menjadi 13.365.

Technical Ideas

Masih melemahnya harga minyak mentah dunia serta lanjutnya pelemahan indeks global diprediksi menjadi sentimen negatif pada hari ini. di sisi lain, sentimen positif datang dari hasil data ekonomi dalam negeri diperkirakan menjadi penopang indeks. IHSG diprediksi bergerak menguat terbatas dengan kisaran support di level 5.245 sedangkan resist pada level 5.300. Beberapa saham yang bisa dicermati antara lain:

- HMSP (Spec Buy, TP: Rp3.980, Support: Rp3.910)
- UNVR (Spec Buy, TP: Rp39.750, Support: Rp39.475)
- BBTN (SELL, Resist: Rp1.900, Support: Rp1.860)
- INAF (Spec Buy, TP: Rp4.300, Support: Rp3.900)

News Highlight

PT Sentul City Tbk (BKSL) akan mengakuisisi PT Graha Sejahtera Abadi (GSA). Langkah ini dilakukan guna menguasai sejumlah lahan yang dimiliki oleh GSA. Akuisisi ini dilakukan melalui penyeteroran aset. Untuk pengambil alih tersebut, BKSL akan menggelar penawaran umum terbatas dengan hak memesan efek terlebih dahulu atau right issue. Right issue sekaligus dilakukan untuk memperbaiki struktur permodalan perusahaan. BKSL akan meminta persetujuan dalam rapat umum pemegang saham luar biasa (RUPSLB).

PT Provident Agro Tbk (PALM) akan mengurangi modal usaha yang ditempatkan dan disetorkan perseroan. Hal ini dilakukan setelah mendapatkan persetujuan dalam RUPSLB. Keputusan ini diambil karena perseroan mengalami kelebihan likuiditas sebagai dampak penjualan aset berupa empat entitas anak perusahaan pada tahun 2016. Dengan penjualan itu, dana yang berhasil di raup oleh perseroan yaitu Rp2,7 triliun. Pengurangan modal ini tidak akan berdampak negatif pada perusahaan terutama untuk memenuhi kewajiban pada kreditur. Pasalnya perseroan masih memiliki dana untuk memenuhi kewajiban.

PT Inti Bangun Sejahtera Tbk (IBST) menjual sebagian saham PT Palapa Timur Telematika yang merupakan badan usaha pelaksana proyek palapa ring paket timur (PTT) kepada perusahaan afiliasi yaitu PT Infrastruktur Bisnis Sejahtera (IBWT). Perseroan menjual 26% saham perseroan atau 268 lembar saham dengan nilai Rp3,1 miliar. Transaksi ini dilakukan untuk mendapatkan perusahaan yang bergerak di bidang usaha yang dapat mendukung Palapa Timur Telematika, badan usaha Pelaksana Proyek Pala Ring Paket Timur.
