Global Market Wrap

Bursa saham Wall Street pada perdagangan hari Kamis di tutup bervariasi setelah mencatatkan kenaikan terbaru karena pelaku pasar masih mencermati kinerja laporan keuangan. Dow Jones ditutup menguat 32 poin (+0,16%) di level 20.101, Nasdaq ditutup turun 1 poin (-0,02%) pada level 5.655. Dari regional, indeks Nikkei dibuka menguat 58 poin (+0,30%) di level 19.460. Nilai tukar rupiah pada hari ini dibuka melemah 42 poin (-0,32%) menjadi 13.374.

Technical Ideas

Naiknya harga minyak mentah dunia dan kinerja laporan keuangan yang mulai rilis diprediksi menjadi sentimen positif indeks, di sisi lain bervariasinya bursa saham Wall Street dan aksi ambil untung di akhir pekan diperkirakan menjadi katalis negatif pada hari ini. IHSG diprediksi bergerak menguat terbatas dengan kisaran *support* di level 5.290 sedangkan *resist* pada level 5.340. Beberapa saham yang bisa dicermati antara lain:

- ASRI (Spec Buy, TP: Rp398, Support: Rp382)
- BBKA (Spec Buy, TP: Rp15.600, Support: Rp15.000)
- PGAS (Spec Buy, TP: Rp2.810, Support: Rp2.650)
- INTIP (Spec Buy, TP: Rp15.950, Support: Rp15.200)

News Highlight

PT Semen Batu Raja Tbk (SMBR) menjadi salah satu emiten yang pergerakan sahamnya cukup tinggi pada tahun lalu. Pada tahun ini, kinerja perusahaan dapat tumbuh sejalan dengan outlook konsumsi semen yang diprediksi masih akan naik. SMBR membidik pertumbuhan penjualan 23% dari tahun lalu menjadi 2 juta ton. Peningkatan penjualan itu juga sejalan dengan supply perusahaan yang meningkat, jika pabrik Semen Baturaja II beroperasi di pertengahan tahun ini.

PT Matahari Putra Prima Tbk (MPPA) peritel multi-format modern yang mengoperasikan Hypermart, Smartclub, Foodmart, Boston Health & Beauty dan FMX, memulai ekspansi bisnisnya pada 2017 dengan membuka gerai Foodmart Fresh. Perseroan berharap kehadiran Foodmart Fresh mampu melayani kebutuhan masyarakat di area BSD dan sekitarnya akan produk-produk berkualitas. Intermark dipilih lantaran terletak di area perumahan dan perkantoran yang sedang berkembang.

PT Sumi Indo Kabel Tbk (IKBI) mengalami penurunan penjualan tahunan pada 2016. Meski demikian, perseroan mencatatkan kenaikan laba bruto. Hal ini disebabkan beban pokok penjualan tahun kemarin lebih kecil dari tahun 2015. Penjualan ini terdiri dari penjualan di dalam negeri sebesar US\$25,2 juta dan penjualan ekspor itu sekitar US\$72,7 juta. Selain itu, penjualan juga kebanyakan berupa transaksi kepada perusahaan berelasi yaitu sekitar US\$77 juta atau sekitar 78,6%.
