## Global Market Wrap

Bursa saham Wall Street pada perdagangan akhir pekan di tutup bervariasi, tetapi masih mencatatkan kenaikan selama seminggu terakhir selama pelaku pasar masih melihat pemilihan Presiden Perancis. Dow Jones ditutup menguat 4 poin (+0,02%) di level 20.624, Nasdaq ditutup naik 23 poin (+0,41%) pada level 5.838. Dari regional, indeks Nikkei dibuka melemah 65 poin (-0,34%) di level 19.169. Nilai tukar rupiah pada hari ini dibuka melemah 16 poin (-0,12%) menjadi 13.349.

## Technical Ideas

Bervariasinya bursa saham Wall Street serta harga komoditas yang ikut menurun seiring dengan minimnya sentimen positif dalam negeri diprediksi menjadi katalis negatif indeks. IHSG diprediksi bergerak melemah dengan kisaran *support* di level 5.330 sedangkan *resist* pada level 5.370. Beberapa saham yang bisa dicermati antara lain:

- CTRA (BoW, Resist: Rp1.390, Support: Rp1.355)
- SCMA (Spec Buy, TP: Rp2.850, Support: Rp2.780)
- SMBR (Spec Buy, TP: Rp2.270, Support: Rp2.210)
- PPRO (SELL, Resist: Rp350, Support: Rp334)

## News Highlight

**PT Pakuwon Jati Tbk (PWON)** melalui anak usahanya yaitu Pakuwon Prima akan menerbitkan Surat Utang Baru yang dicatatkan dan diperdagangkan di SGX-ST. Obligasi ini bernilai US\$250 juta atau ekuivalen dengan mata uang rupiah sebesar Rp3,2 triliun. Surat utang tersebut akan jatuh tempo per tanggal 14 Februari 2024 yang akan datang. Sementara itu, surat utang ini memiliki tingkat bunga tetap sebesar 5% per tahun. Dana tersebut akan digunakan perseroan untuk melunasi Surat Utang 2019 dan tujuan umum perusahaan.

**PT Midi Utama Indonesia Tbk (MIDI)** meraup pendapatan sebesar Rp8,4 triliun di sepanjang tahun 2016. Pendapatan ini naik sekitar 18,3% dibandingkan dengan pendapatan perseroan di tahun 2015 yaitu sebesar Rp7,1 triliun. Seiring dengan peningkatan pendapatan, beban dari perseroan juga meningkat ke level Rp6,3 triliun atau mengalami peningkatan beban sebesar 18,8%. Sementara itu laba perseroan mengalami kenaikan laba sebesar 40% menjadi Rp196 miliar. Pendapatan makanan masih menjadi kontribusi pendapatan utama MIDI sebesar Rp5,7 triliun. Sementara pendapatan dari segmen non-makanan berkontribusi sebesar Rp2,6 triliun.

# INDOPREMIER

**PT Sumber Alfaria Trijaya Tbk (AMRT)** menutup tahun lalu dengan catatan positif. Berdasarkan laporan keuangan perusahaan 2016, laba bersihnya tercatat 601,59 miliar. Perolehan ini meningkat sekitar 33% dibanding periode yang sama tahun sebelumnya. Kenaikan laba bersih tersebut tidak lepas dari kenaikan plus efisiensi di sisi *top line* perusahaan. Terlihat dari beban penjualan dan distribusi 2016 yang mengecil menjadi Rp6,93 triliun dari sebelumnya Rp7,48 triliun. Efeknya, laba usaha AMRT mengalami kenaikan sekitar 11% menjadi Rp1,27 triliun. Kenaikan ini turut mempengaruhi laba bersih AMRT yang positif.
