Global Market Wrap

Bursa saham Wall Street pada perdagangan kemarin ditutup bervariasi setelah Bank sentral AS merilis haril rapat the Fed sebelumnya yang memberikan kesimpulan bahwa kenaikan suku bunga akan terjadi lebih cepat. Dow Jones ditutup menguat 32 poin (+0,16%) di level 20.775, Nasdaq ditutup turun 5 poin (-0,09%) pada level 5.860. Dari regional, indeks Nikkei dibuka melemah 104 poin (-0,54%) di level 19.275. Nilai tukar rupiah pada hari ini dibuka menguat 16 poin (+0,12%) menjadi 13.352.

Technical Ideas

Melemahnya harga minyak mentah serta bervariasi bursa saham Wall Street diprediksi menjadi sentimen negatif indeks, di sisi lain masih berlanjutnya data laporan keuangan diperkirakan menjadi katalis positif indeks. IHSG diprediksi bergerak menguat terbatas dengan kisaran *support* di level 5.340 sedangkan *resist* pada level 5.380. Beberapa saham yang bisa dicermati antara lain:

- SMGR (Spec Buy, TP: Rp9.325, Support: Rp9.075)
- AKRA (Spec Buy, TP: Rp6.525, Support: Rp6.175)
- TBIG (Spec Buy, TP: Rp5.350, Support: Rp5.200)
- RALS (Spec Buy, TP: Rp1.330, Support: Rp1.315)

News Highlight

PT PP Properti Tbk (PPRO) akan menggelar penambahan modal dengan memberikan hak memesan efek terlebih dahulu I. Dalam penawaran ini, perusahaan induk PPRO, PT Pembangunan Perumahan Tbk (PTPP), akan menyertorkan dana ke anak usahanya ini Rp1 triliun. Dengan demikian, perseroan mengharapkan kucuran dana dari publik bisa mencapai Rp538 miliar. Sehingga total dana yang bisa dihimpun oleh PPRO sebesar Rp1,54 triliun. PPRO akan menggunakan 70% dana *right issue* untuk pengembangan usaha, sebanyak 20% untuk modal kerja dan 10% untuk refinancing.

PT Wijaya Karya Tbk (WIKA) melalui anak usahanya PT Wijaya Karya Serang Panimbang menandatangi Perjanjian Pengusahaan Jalan Tol (PPJT) dengan Badan Pengusahaan Jalan Tol (BPJT) dan Perjanjian Penjaminan Proyek Tol Serang-Panimbang dengan PT Penjaminan Infrastruktur Indonesia (PPI). Jalan Tol Serang Panimbang merupakan salah satu dari empat ruas jalan tol kerjasama pemerintah dengan badan usaha (KPB) yang mendapat dukungan pemerintah dalam bentuk penjaminan bersama dari Kementerian Keuangan dan PT Penjaminan Infrastruktur Indonesia (PPI). Jalan tol Serang-Panimbang merupakan satu dari proyek strategis nasional yang ditetapkan oleh Pemerintah. Tahun 2017, WIKA memproyeksikan target penjualan sebesar Rp25,747 triliun atau naik 32,81% dari target tahun 2016 sebesar Rp17,29 triliun.

INDOPREMIER

PT Nusa Raya Cipta Tbk (NRCA) menjual kepemilikan sahamnya di PT Baskhara Utama Sedaya senilai Rp223 miliar kepada PT Astratel Nusantara. Perseroan mengatakan tujuan divestasi saham tersebut untuk memperoleh modal tambahan guna membuka peluang investasi baru. Namun, penggunaan dana hasil transaksi tersebut masih belum ditentukan. Perseroan berharap dengan terlaksananya rencana transaksi dapat mendorong perseroan dalam mengembangkan bisnisnya karena akan memberi dampak positif terhadap kondisi keuangan perseroan.
