## Global Market Wrap

Bursa saham Wall Street pada perdagangan hari Kamis ditutup mendatar setelah mencatatkan kenaikan tertinggi, selama pelaku pasar masih menunggu pidato Presiden Donald Trump minggu depan. Dow Jones ditutup menguat 11 poin (+0,05%) di level 20.821, Nasdaq ditutup naik 10 poin (+0,17%) pada level 5.845. Dari regional, indeks Nikkei dibuka melemah 174 poin (-0,90%) di level 19.109. Nilai tukar rupiah pada hari ini dibuka melemah 13 poin (-0,10%) menjadi 13.344.

## Technical Ideas

Menguatnya bursa saham Wall Street serta harga komoditas lainnya diprediksi menjadi sentimen positif indeks pada hari ini. Pelaku pasar juga menanti rilis data ekonomi inflasi yang akan diumumkan pekan ini diperkirakan akan ikut mempengaruhi laju market. IHSG diprediksi bergerak menguat dengan kisaran *support* di level 5.365 sedangkan *resist* pada level 5.410. Beberapa saham yang bisa dicermati antara lain:

- BBRI (Spec Buy, TP: Rp12.050, Support: Rp11.850)
- PTTP (Spec Buy, TP: Rp3.550, Support: Rp3.490)
- MNCN (Spec Buy, TP: Rp1.625, Support: Rp1.555)
- CPIN (Spec Buy, TP: Rp3.460, Support: Rp3.080)

## News Highlight

**PT Surya Semesta Internusa Tbk (SSIA)** berharap menjual lahan lebih besar dibandingkan tahun lalu. SSIA menargetkan nilai penjualan lahan sepanjang 2017 mencapai Rp400 miliar. Jumlah ini meningkat dua kali lipat dibandingkan realisasi penjualan lahan 2016. Tahun ini, SSIA akan menambah 500 ha lahan. Emiten ini telah menyiapkan dana Rp800 miliar untuk akuisisi lahan. Dana itu berasal dari belanja modal Rp1,5 triliun. Sebagian capex juga berasal dari kas internal dan pinjaman. SSIA juga akan memiliki kesiapan dana untuk pengembangan Subang. Dana tersebut berasal dari divestasi ruas tol Cipali sebesar Rp2,5 triliun. Perseroan akan meminta persetujuan pemegang saham terkait divestasi ini.

**PT Indo Tambangraya Megah Tbk (ITMG)** langkah efisiensi tahun lalu membuat hasil positif. Perseroan mencetak laba bersih di 2016 hingga US\$130,71 juta. Angka itu melonjak 107,13% dibanding raihan pada 2015 yang hanya US\$63,1 juta. Area penjualan utama batubara ITMG masih di wilayah Asia Tenggara, India, dan Pakistan yang menyumbang pendapatan mencapai US\$497 juta. Sementara penjualan domestik berkontribusi sebesar 13% dari total pendapatan perseroan. Tahun ini, ITMG menargetkan produksi batubara sebanyak 26,2 juta ton. Mereka menyiapkan belanja modal sebesar US\$38 juta, atau sama dengan tahun lalu.

**PT Astra Otoparts Tbk (AUTO)** sepanjang 2016 mencetak laba bersih mencapai Rp418,2 miliar. Jumlah ini meningkat 31% dibandingkan dengan pencapaian di 2015 yang hanya Rp318,57 miliar. Kenaikan laba bersih AUTO itu tak lepas dari pertumbuhan pendapatan mereka tahun lalu yang meningkat 9% menjadi Rp12,81 triliun. Pada tahun sebelumnya, pendapatan AUTO tercatat hanya sebesar Rp11,72 triliun. Di sisi lain, beban pokok AUTO juga mengalami kenaikan 9% jadi Rp10,95 triliun
