## Global Market Wrap

Bursa saham Wall Street pada perdagangan kemarin ditutup menguat karena pelaku pasar berharap adanya petunjuk dari Presiden Donald Trump selama perdagangan. Dow Jones ditutup menguat 43 poin (+0,21%) di level 20.938, Nasdaq ditutup menguat 5 poin (+0,08%) pada level 6.139. Dari regional, indeks Nikkei dibuka menguat 107 poin (+0,55%) di level 19.720. Nilai tukar rupiah pada hari ini dibuka melemah 14 poin (-0,11%) menjadi 13.313.

## Technical Ideas

Menguatnya bursa saham Wall Street seiring dengan kenaikan pada harga minyak mentah dunia diprediksi menjadi sentimen positif indeks, di sisi lain pelaku pasar yang menunggu hasil rapat FOMC serta keputusan OPEC diprediksi akan menghambat laju market. IHSG diprediksi bergerak menguat terbatas dengan kisaran *support* di level 5.690 sedangkan *resist* pada level 5.770. Beberapa saham yang bisa dicermati antara lain:

- ICBP (Spec Buy, TP: Rp8.900, Support: Rp8.750)
- INAF (SELL, Resist: Rp4.170, Support: Rp3.710)
- ACES (Spec Buy, TP: Rp1.000, Support: Rp970)
- BDMN (SoS, TP: Rp5.600, Support: Rp5.400)

## News Highlight

**PT Mitra Adi Perkasa Tbk (MAPI)** menganggarkan belanja modal tahun ini sebesar Rp750 miliar. Capex tersebut bersumber dari kas internal. Sebagian besar capex tersebut digunakan untuk ekspansi toko-toko baru. Rencananya, tahun ini MAPI ingin menambah luas toko sebanyak 70.000 meter persegi. Diantaranya terbagi menjadi 20 ribu m2 untuk perluasan departemen store, 40 ribu m2 untuk menambah speciality stores, dan 10 ribu m2 untuk menambah gerai food and beverage. Sebagian gerai tersebut diantaranya 50% berada di dalam Jakarta. Sedangkan 50% lainnya berada di luar Jakarta, termasuk di antaranya gerai Zara di Vietnam. Sementara itu, dengan rencana ekspansi tersebut, MAPI membidik pertumbuhan penjualan 2017 sebesar 13%-14%.

**PT Siloam International Hospitals Tbk (SILO)** mengumumkan telah mengakuisisi Rumah Sakit Umum Putera Bahagia (RSUPB) di Cirebon. Adapun nilai akuisisi mencapai Rp130 miliar. Akuisisi ini akan segera berkontribusi pada pendapatan perseroan. Melalui akuisisi ini, Siloam berencana untuk meningkatkan kapasitas tempat tidur dan memperbaiki fasilitas serta layanan dengan menginstal peralatan medis *state-of-the-art medical equipment* seperti MRI dan CT-Scan. Akuisisi ini akan semakin memperkuat kehadiran Siloam di daerah Jawa Barat sebagai rumah sakit ke-10 perseroan yang berlokasi di provinsi terpadat di Indonesia dengan 47 juta penduduk.

**PT Intraco Penta Tbk (INTA)** melanjutkan aksi korporasi penambahan modal dengan HMETD I. INTA akan menerbitkan 1,16 miliar saham baru dengan harga pelaksanaan Rp200 per saham. Sehingga total dana *right issue* INTA mencapai Rp232,62 miliar. INTA akan menggunakan seluruh dana *right issue* untuk akuisisi 30% saham PT Petra Unggul Sejahtera, perusahaan terafiliasi INTA, dengan nilai Rp337,5 miliar. Selain membayar dalam bentuk tunai, INTA juga akan membayar dalam bentuk non tunai. Pembeli siaga *right issue* INTA yang juga pemegang saham INTA, akan mengeksekusi HMETD dengan mengalihkan saham Petra Unggul sebanyak-banyaknya Rp232,62 miliar.
