## Global Market Wrap

Bursa saham Wall Street pada perdagangan hari Rabu di tutup melemah karena pasar kembali tertekan oleh penurunan pada harga minyak mentah. Dow Jones ditutup melemah 57 poin (-0,27%) di level 21.410, Nasdaq ditutup naik 46 poin (+0,74%) pada level 6.234. Dari regional, indeks Nikkei dibuka naik 9 poin (+0,05%) di level 20.148. Nilai tukar Rupiah pada hari ini dibuka menguat 13 poin (+0,10%) menjadi 13.305.

## Technical Ideas

Melemahnya bursa saham Wall Street serta turunnya harga minyak mentah diprediksi menjadi sentimen negatif indeks. Minimnya sentimen dalam negeri juga akan mempengaruhi laju indeks. IHSG diprediksi bergerak menguat terbatas dengan kisaran *support* di level 5.775 sedangkan *resist* pada level 5.840. Beberapa saham yang bisa dicermati antara lain:

- ITMG (Spec Buy, TP: Rp18.150, Support: Rp17.550)
- JPFA (Spec Buy, TP: Rp1.370, Support: Rp1.330)
- EXCL (Spec Buy, TP: Rp3.480, Support: Rp3.140)
- LPKR (Spec Buy, TP: Rp660, Support: Rp635)

## News Highlight

**PT Telekomunikasi Indonesia Tbk (TLKM)** memproyeksikan pendapatan hingga akhir tahun tumbuh dua digit. Perseroan mengungkapkan dinamika dalam industri telekomunikasi sangat tinggi sekali. Untuk tahun ini, industri secara keseluruhan bisa tumbuh 8%-9% yoy. Perseroan ingin tumbuh di atas rerata industri telekomunikasi. Adapun nilai kas dan setara kas pada periode akhir Maret 2017 mencapai Rp33,69 triliun, atau mengalami penurunan dari posisi Rp35,73 triliun pada periode yang sama tahun sebelumnya. Menjelang lebaran, TLKM telah memiliki tim satuan tugas yang mengawal aktivitas telekomunikasi akan berjalan dengan lancar.

**PT MAP Boga Tbk (MAPB)** membidik pertumbuhan penjualan sebesar 15% pada 2017. Manajemen mengatakan perusahaan sedang berkembang dalam tahap ekspansif. Dalam tiga tahun terakhir, pendapatan yang dikantongi emiten mencapai Rp1 triliun pada 2014, Rp1,32 triliun pada 2015, dan Rp1,62 triliun pada 2016. Paruh pertama tahun ini kinerja perseroan relatif stabil seiring kondisi perekonomian nasional. Dana segar hasil penawaran umum perdana saham sebesar Rp37,25 miliar akan digunakan untuk belanja modal pembukaan gerai baru.

**PT Barito Pacific Tbk (BRPT)** menggandeng The Siam Cement Public Company Limited untuk membentuk perusahaan patungan yang bergerak di bidang logistik. Perseroan mengatakan anak usaha yaitu PT Barito Investa Prima dengan SCG Cement Building Materials Co. Ltd anak usaha The Siam Cement Public Company Limited sepakat untuk membentuk anak usaha patungan di bidang logistik melalui PT SCG Barito Logistics. Perseroan dan SCG Cement Building Materials Co. Ltd tidak memiliki hubungan afiliasi. Kepemilikan saham PT Barito Investa Prima sebesar 51% dalam perusahaan patungan tersebut.
