Indonesia Market Wrap

Pada perdagangan hari ini indeks harga saham gabungan konsisten bergerak di zona hijau dipicu oleh sentimen positif dari rilis data inflasi yang lebih rendah dari konsensus di level 5,28% vs 5,40% yoy serta 0,34% vs 0,45% mom. Sementara itu menguatnya indeks di bursa Wall Street dan naiknya harga komoditas nikel dan emas turut menjadi sentimen positif tambahan bagi pergerakan indeks.

IHSG ditutup menguat +23 poin (+0,34%) pada level **6.862**. Sektor transportasi dan sektor barang konsumen non primer yang mengalami kenaikan +33 poin (+1,86%) dan +10 poin (+1,27%) menjadi kontributor terbesar bagi kenaikan indeks harga saham gabungan hari ini.

Nilai tukar rupiah terhadap dolar Amerika menguat +15 poin (+0,10%) pada level **Rp14.975**.
